

GENERAL RULES AND TERMS OF PARTICIPATION IN THE "ELIPAY AIRDROP" PRIZE CONTEST

TERMS OF PARTICIPATION

"Eli Airdrop" (hereinafter referred to as the **Prize contest**) is a prize contest in which the organizer will, in accordance with the terms explained below, award a prize to adult users who have already created their user account in the Elipay mobile application (hereinafter referred to as **Elipay**) and successfully completed the level 1 identification where they had their identity confirmed by the organizer (hereinafter referred to as **Participants**) in accordance with the [General Terms of Use of the Elipay Mobile Application](#).

ORGANIZER

Organizer of the contest is Eligma d.o.o., Letališka 33F, 1000 Ljubljana (hereinafter referred to as **Eligma**).

Responsible for the organization, implementation and supervision of the Prize contest process is a panel consisting of Eligma representatives (hereinafter referred to as the **Panel**).

PRIZE CONTEST RULES AND DURATION

100 Participants will receive **1000 ELI tokens each** (hereinafter referred to as the **Prize**) in accordance with the following terms:

- Prize will be awarded to the first 30 Participants who will successfully register Elipay and complete the level 1 identification process in the period from 2 December 2018 (Prize contest starts at 20:00) to 4 December 2018 (Prize contest ends at 23:59);
- Prize will be awarded to the next 70 Participants who will successfully register Elipay and complete the level 1 identification process in the period from 5 December 2018 (Prize contest starts at 20:00) to 10 December 2018 (Prize contest ends at 12:00).

Participants will receive the award in their digital wallet no later than 24 (twenty-four) hours after a successfully completed level 1 identification procedure where they had their identity confirmed by the organizer and fulfilment of the conditions set out in the preceding paragraph.

General Rules and Terms of participation in the Prize contest are published on the www.elipay.com website.

PRIVACY INFORMATION

As the data controller, Eligma respects the privacy of the Participants. Eligma undertakes to process personal data obtained for the purpose of carrying out the Prize contest carefully and to protect and process them in accordance with the Personal Data Protection Act (*Zakon o varstvu osebnih podatkov*), General Data Protection Regulation (GDPR) and other applicable relevant legislation.

By taking part in the Prize contest, the Participant consents Eligma to process its personal data (name and surname, address, telephone, e-mail address) for the purpose of carrying out the Prize contest and awarding prizes in the capacity of a data controller. Participants' personal data is processed and stored in accordance with the current data protection legislation.

The Participant further consents Eligma to use personal data from the previous paragraph for the purposes of statistical processing, potential customer segmentation and for the purposes of direct marketing of Eligma's products and services.

Eligma accepts no responsibility for data protection on websites linked to by potential links on its websites, or the responsibility for potential mistakes that can arise from providing incorrect or false data by the Prize contest Participants.

Each Participant has the right to request access, transcript, supplementation, correction, blocking or deletion of their personal data or withdraw its consent to process its personal data from Eligma in accordance with the applicable regulation. BREACH OF THE TERMS OF PARTICIPATION

The Participant loses the right to participate if Eligma finds that the Participant has breached the General Rules and Terms for the Prize contest.

OTHER PROVISIONS

Eligma reserves the right to amend and change the General Rules and Terms for the Prize contest for reasons of technical or commercial nature or reasons beyond Eligma's control.

Eligma will keep the Participants informed on all changes and novelties by publishing them on its website or in other public media.

These General Rules and Terms for the Prize contest are governed by the laws of the Republic of Slovenia.

In the case of any disputes arising out of or in connection with these General Rules and Terms for the Prize contest, the competent court is the Court of Ljubljana.
