



GENERAL RULES AND TERMS OF PARTICIPATION IN THE "RECEIVE 5 € AND TRY OUT CRYPTO SHOPPING" PRIZE CONTEST

TERMS OF PARTICIPATION

"Receive 5 € and try out crypto shopping" (hereinafter: the **Prize Contest**) is a prize contest in which the organizer will, in accordance with the terms below, award a prize to adult users who have created their user account in the Elipay mobile application and will successfully complete the Tier 1 identification process, followed by an identity verification made by the organizer (hereinafter: the **participants**), in accordance with [the General Terms of Use of the Elipay Mobile Application](#).

The prize is the following:

ELI tokens in the value equivalent of 5 EUR.

The price of the ELI token and the consequent total of the ELI tokens are determined on the day when a participant receives the ELI tokens into their digital wallet. The price is published on the website of the CoinCodex cryptocurrency exchange aggregator (<https://coincodex.com>). The price of the ELI token is set with four decimal points.

A participant receives the ELI tokens into their digital wallet no later than 7 (seven) days after they successfully complete their Tier 1 identification by means of an identity verification made by the organizer.

ORGANIZER

The Prize Contest organizer is Eligma d.o.o., Letališka 33F, 1000 Ljubljana (hereinafter: **Eligma**).

Responsible for the organization, implementation and supervision of the Prize Contest process is a panel consisting of Eligma representatives (hereinafter: the **Panel**).

PRIZE CONTEST DURATION

The Prize Contest will take place from 19 December 2018 (start at 00:00:01 CET) to 31 January 2018 (finish at 23.59:59 CET). In this period, the participants will be able to complete the Tier 1 identification process with the right to receive the prize.

Eligma reserves the right to extend the duration of the Prize Contest.

The general rules and terms of participation in the Prize Contest are published on the www.elipay.com website.

PERSONAL DATA PROTECTION

As the controller of the data of the participants, Eligma respects the privacy of the participants. Eligma undertakes to handle personal data obtained for the purpose of carrying out the prize contest carefully and to protect and process them in accordance with the Personal Data Protection Act, General Data Protection Regulation (GDPR) and other applicable legislation.

By entering the Prize Contest, the participant allows Eligma to process their personal data (name and surname, address, telephone, e-mail address) for the purpose of carrying out the



Prize Contest and awarding prizes in the capacity of a personal data controller. The personal data of the participants is used and stored in accordance with the applicable legislation in the field of personal data protection.

The participant further allows Eligma to use the personal data from the previous paragraph for the purposes of statistical processing, potential customer segmentation and for the purposes of direct marketing of Eligma's products and services.

Eligma accepts no responsibility for the data protection on websites linked to by potential links published on its websites, or the responsibility for potential mistakes that can arise from providing incorrect or false data on part of the Prize Contest participants.

At any point, each participant can request to view, transcribe, amend, correct, block or delete their personal data or withdraw their consent to its processing, in accordance with the relevant regulations. They can send their request to dpo@eligma.com.

OTHER PROVISIONS

Eligma reserves the right to amend and change the General Terms of the Prize Contest for reasons of technical or commercial nature or reasons beyond Eligma's control.

Eligma will keep the Participants informed on all changes and novelties by publishing them on its website.

These General Terms of the Prize Contest are judged under the law of the Republic of Slovenia.

In the case of any disputes arising out of or in connection with these General Terms of the Prize Contest, the competent court is the Court of Ljubljana.
